

POVABILO K IZKAZU INTERESA (NEPREMIČNINE)

Družba Sberbank banka d.d., Dunajska c. 128a, 1000 Ljubljana, matična številka 5496527000 (v nadaljevanju „Banka“) v svojem imenu in za svoj račun objavlja predmetno povabilo k izkazu interesa za nakup nepremičnin v lasti banke.

1. Predmet predvidene prodaje

Banka preučuje možnosti prodaje lastnih nepremičnin z naslednjimi ID znaki:

- 1) ID 703-49/2 (objekt z zemljiščem v lasti Sberbank d.d.)
- 2) 703-41/33 (dostop do obeh objektov v lasti Privatinvest d.o.o.)

Navedene nepremičnine se namerava prodati kot nedeljivo celoto. Nepremičnine, navedene pod točko 1, se v nadaljevanju navajajo tudi kot »Nepremičnine«.

2. Predhodni postopek – izkaz interesa

Predmetni postopek vodi Banka z namenom pridobitve informacij, ki so pomembne za presojo najugodnejših pogojev prodaje. V postopku lahko sodelujejo domače in tuje fizične in pravne osebe, ki skladno z veljavno zakonodajo Republike Slovenije smejo pridobiti Nepremičnine, ki so predmet tega povabila.

Banka bo obravnavala izkazan interes za odkup Nepremičnin, ki bo v pisni obliki (poštna pošiljka ali e-pošta na v 4. točki tega povabila navedene kontakte) prispel v Banko najpozneje do vključno 30.07.2021.

2.1 Vsebina

V predhodnem postopku predvidene prodaje Nepremičnin bo Banka upoštevala pravočasno izkazan interes za nakup Nepremičnin ali nezavezujoče ponudbe, ki naj vsebuje zlasti:

- navedbo, da je pošiljatelj zainteresiran za nakup Nepremičnin,
- predstavitev kupca,
- indikativno ceno.

INVITATION TO EXPRESS INTEREST (REAL ESTATE)

Sberbank Banka d.d., Dunajska c. 128a, 1000 Ljubljana, registration number 5496527000 (hereinafter: the Bank), in its name and on its own behalf publishes this invitation to express interest to purchase real estate owned by the Bank.

1. The subject of sale

The Bank is contemplating to sell its own real estate with below ID numbers:

- 1) ID 703-49/2 (objekt z zemljiščem v lasti Sberbank d.d.)
- 2) 703-41/33 (dostop do obeh objektov v lasti Privatinvest d.o.o.)

The aforementioned real estate are expected to be sold as an indivisible whole. The real estate listed under point 1 will hereinafter also be referred to as "Real Estate".

2. Preliminary procedure – express interest

The present process is led by the Bank in order to obtain information relevant for the assessment of the most favourable terms of the sale. The process is open to domestic and foreign individuals and legal entities, who may obtain Real Estate subject of this invitation in accordance with the valid legislation of the Republic of Slovenia.

The Bank will consider an expressed interest for the purchase of Real Estate received by the Bank in written form (by post or e-mail at contacts listed in point 4 of this invitation) until 30.07.2021.

2.1 Content

In the preliminary procedure of the contemplated sale of Real Estate, the Bank will consider timely expressed interest for purchase of Real Estate or non-binding offers, which inter alia shall include:

- 3) an indication, that the sender is interested for purchase of the Real Estate,
- 4) a presentation of the buyer,
- 5) an indicative price.

Po preučitvi izkazanega interesa ali morebitnih nezavezujočih ponudb bo Banka predvidoma (ni pa k temu zavezana) izvedla standardni postopek za prodajo Nepremičnin, ki bo med drugim vključeval razpis za prodajo Nepremičnin, sklenitev dogovora o nerazkrievanju, možnost skrbnega pregleda, izvedbo ocene prispelih ponudb, preveritev KYC s preveritvijo izvora sredstev, itd.

3. Nezavezujoče povabilo in izključitev odškodninske odgovornosti Banke
